Textual Information(2)	As on 30.06.2026, 21,96,769 (98.61% of the total promoter and promoter group holding) Equity Shares are held in dematerialized form out of 22,27,789 (69.59% of total capital) Equity Shares held under the Promoter and Promoter Group.
